THE AMERICAN UNIVERSITY OF SHARJAH ADVISORY COUNCIL OF DEVELOPMENT AND OUTREACH **TERMS OF REFERENCE**

Introduction

Founded in 1997, the American University of Sharjah (AUS) is an independent, not-for-profit, coeducational institution based on an American model of higher education. AUS's growth and progress since its foundation was overseen by its founder and long-serving President **His Highness Sheikh Dr. Sultan bin Mohammed Al Qasimi**. To usher in a new era of leadership, **Sheikha Bodour bint Sultan Al Qasimi** was appointed Chairperson of the Board of Trustees and President in January 2023 as AUS celebrated its silver jubilee.

With Sharjah's rapid growth and development, AUS has an unprecedented opportunity to significantly increase its aspirations and redefine its relationship with industry, government, innovation and entrepreneurship ecosystem stakeholders, and other high profile global partners. For this reason, the Advisory Council of Development and Outreach (ACDO), a voluntary body that supports partnership development, securing resources for AUS's growth, and stakeholder outreach, was formed. Chaired by AUS's President, the ACDO includes prominent alumni and distinguished global and community leaders.



Mandate and Member Responsibilities

The ACDO serves in an advisory capacity as AUS seeks to increase its contribution to Sharjah's socio-economic, workforce, and innovation priorities while deepening its commitment to excellence in teaching, learning, research, and creative work.

ACDO members support AUS in:

Partnership Development:

Initiating and building relationships with philanthropic, corporate, government, and community leaders to form partnerships and build support for initiatives, programs, contract research, and to increase student employability.

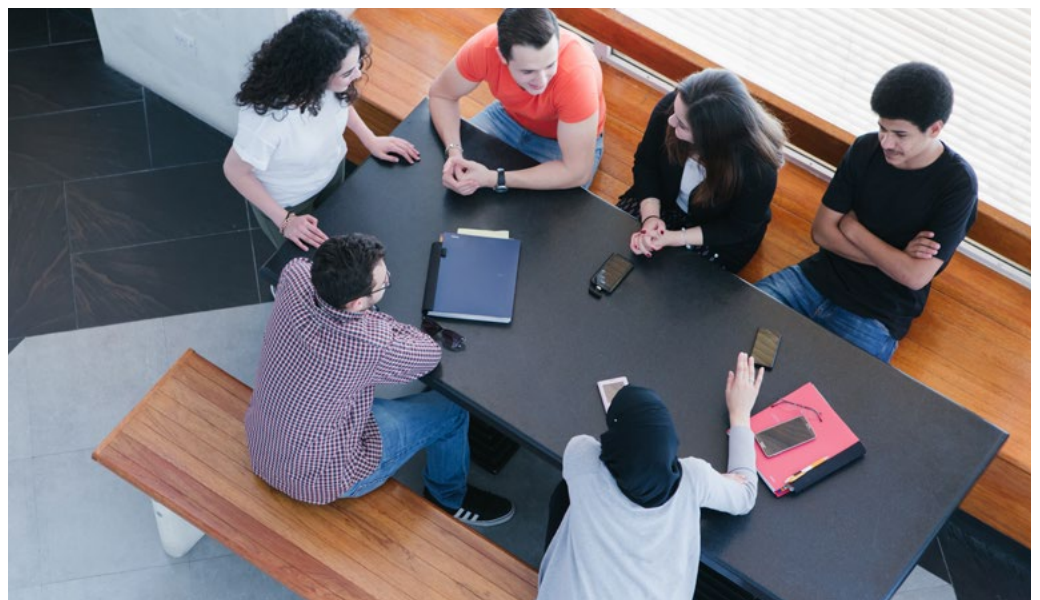
Resource Development:

Cultivating relationships with philanthropic, corporate, government, and community leaders that can result in significant financial support to enhance research, teaching, and community impact.

Local, Regional, and International Outreach:

Amplifying AUS's value and differentiation to promote research collaboration, increase student diversity, and raise its global profile and visibility.

The ACDO will also address other priority institutional opportunities and challenges as needed.



Membership and Terms

Composition and Appointment:

The ACDO is comprised of at least fifteen members appointed for an initial three-year term with the possibility of renewal for an additional term. The President, Chancellor, Chairperson of the Board of Trustees' Resource Development Committee, and the Executive Director of the Office of Advancement and Alumni Affairs are ex-officio members.

Nominations:

Nominations for appointments and to fill vacancies are submitted to the Chairperson. Member nominations are approved by the Board of Trustees on the recommendation of the Board of Trustees' Resource Development Committee.



Officers

Chairperson:

The Chairperson, who leads the ACDO and presides over meetings, is AUS's President. The Chairperson sets the meeting agenda in consultation with the Vice Chairpersons, and, with the support of the Vice Chairpersons, oversees the implementation of ACDO recommendations.

Vice Chairpersons:

The Chairperson can appoint up to two distinguished global or community leaders, or ACDO members, as Vice Chairpersons. Vice Chairpersons assist the Chairperson in carrying out the Council's mandate, overseeing the implementation of ACDO recommendations, and, in the absence of the Chairperson, assume the power and responsibilities of the Chairperson.

Secretary:

The Executive Director of the Office of Advancement and Alumni Affairs is the Secretary. The Secretary maintains records of meetings and follow-ups, prepares and distributes meeting materials, handles meeting logistics, and manages correspondence.

Meetings

The ACDO meets once annually on the AUS campus with ad-hoc meetings scheduled to address urgent, unanticipated, or time-sensitive matters as needed. The agenda and meeting materials will be distributed to members at least three weeks before meetings or at least 24 hours in advance of ad-hoc meetings.

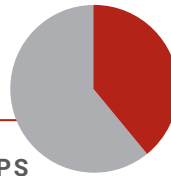

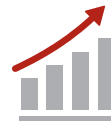
